## Gladstone Land Announces No Damage to Florida Farms from Hurricane Dorian and Provides Update on Recent Acquisition Activity

MCLEAN, Va., Sept. 05, 2019 (GLOBE NEWSWIRE) -- Gladstone Land Corporation (NASDAQ: LAND) ("Gladstone Land" or the "Company") announces no damage to its farms and farm facilities in Florida in the wake of Hurricane Dorian.

"We have spoken to our tenant-partners across the state who reported no crop losses or property damage," said Bill Frisbie, Managing Director of Gladstone Land. "We are grateful to have come out unscathed, given the strength of this historic storm."

"Farmers who rent our farms know that we stand behind our farms and are ready to help where needed, but we are thankful that there was no significant damage sustained as a result of this storm," said David Gladstone, President and CEO of Gladstone Land. "Most of our farms in Florida grow annually-planted crops rather than trees, such as orange trees that are often grown in Florida. By not having orchards in Florida, we avoid the loss of the trees when there are strong winds."

"On another note, we continue to add to the strength and diversity of our farmland holdings in the U.S. Since June 30, 2019, the Company has acquired over \$153 million of new farms. This is a substantial increase since we last reported, and we now own about 82,000 acres across ten states. These recent acquisitions should add nicely to the revenue and earnings for the remainder of 2019."

### About Gladstone Land Corporation:

Founded in 1997, Gladstone Land is a publicly traded real estate investment trust that owns farmland and farm-related properties located in major agricultural markets across the U.S. and leases its properties to unrelated third-party farmers. The Company reports the fair value of its farms on a quarterly basis. The Company currently owns 95 farms, comprised of approximately 82,000 acres in 10 different states, valued at approximately \$821 million. The farms are predominantly located in regions where its tenants are able to grow fresh produce annual row crops, such as berries and vegetables, which are generally planted and harvested annually. The Company also owns farms growing permanent crops, such as almonds, apples, figs, olives, pistachios, and other orchards, as well as groves of blueberries and vineyards, which are generally planted every 10 to 20-plus years and harvested annually. The Company may also acquire property related to farming, such as cooling facilities, processing buildings, packaging facilities, and distribution centers. The Company pays monthly distributions to its stockholders and has paid 79 consecutive monthly cash distributions on its common stock since its initial public offering in January 2013. The current per-share distribution on its common stock is \$0.04455 per month, or \$0.5346 per year.
